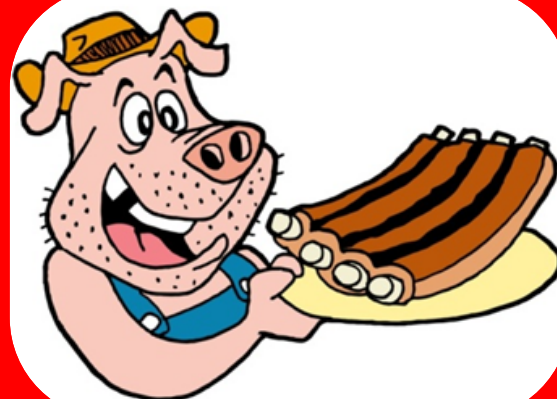

Darin Scott (Jackson HS Boys)

Scott is a graduate of Fox High School. He coached for four years at Notre Dame High School. While there, he won two District Championships. Scott has been coaching at Jackson High School for the past 10 years. While at Jackson, Scott has won five District Championships and for the past two years has made it to the Class 5 Quarterfinals. While coaching the Indians, they earned the honors of SEMO Conference champs two times, Southeast Missourian Christmas Champions three times and SEMO Conference Champs. Scott has also earned the honor of SEMO Conference Coach of the Year twice. During his coaching career he has 271 wins and 170 losses.

Brad Botsch (Bernie HS Boys)

Botsch is a graduate of Bernie High School. He obtained his Masters Degree in Administration from William Woods University. After completing his undergraduate degree from SEMO in 2001, He became head coach in 2006, and has since compiled a 184-54 record in 8 seasons at the helm of the Mules. During this stretch, the Mules have been: (3X) SCAA Tournament Champions, (4X) SCAA Conference Champions, (1X) Bloomfield Christmas Tournament Champions, (6X) Bernie Invitational Champions, (4X) District Champions, and (2X) Class 2 Final Four with 2 second place finishes.

Jim Vaughan (Kennett HS Boys)

Vaughn is a graduate of Fairfield HS/Greenville College. He was a 3 sport athlete in HS and went on to play small college football at Greenville where he was a four year starter. But Vaughan's passion was always in basketball. He began his career in Missouri serving as an assistant at Poplar Bluff for 7 years, where they went to the final in '03. He then left to pursue his head coaching career the next year at Twin Rivers HS. Vaughan's teams compiled a 62-22 record and captured two OFC titles and one Oran title, in which he was named OFC Coach of the Year in '04. He moved on to Kennett and has been there for the past 8 years. In his second season, Kennett won its first Bootheel Conference Tournament title in school's history in '08, and those years, he was named Coach of the Year. Kennett has also captured for Bloomfield Christmas Tournament Championships and one district title in '10, which is only the school's second ever, and has made the only appearance in school's history in the state quarterfinals. Vaughan's overall coaching career record is 183-109.

Chad Allen (Dexter HS Girls)

Allen is a graduate of Sylvan Hills HS/Three Rivers CC/University of Memphis. As a player, finished 2nd & 5th in the nation at TRCC, played in NCAA tournament at Memphis, and played professional basketball in Europe. Allen has been at the helm of the Lady Bearcat basketball team at Dexter HS for the past 7 seasons. His teams have compiled an overall record of (162-39). During the past 7 seasons the Lady Bearcats have been: (6X) Lady Royals Christmas Champions, (2X) McDonlad's Shootout Champions, (4X) SEMO Conference Champions, (6X) District Champions, and (3X) Class 4 Final Four with 2 fourth place finishes & a second place finish. As a result of his teams' successes, he has been awarded: (4X) SEMO Conference Coach of the Year, (6X) MOBCA District Coach of the Year, and (5X) BA Sports All-Star Coach of the Year.

Louis Bell (Clearwater HS Boys)

Bell is a graduate of Clearwater High School/Mineral Area College/Missouri Baptist College. As a player, Bell was a 2 time All-District Basketball player in High School and played 4 years of College Basketball. As a coach, Bell has been at the helm of the Clearwater Tigers for the past 11 seasons. This past season, Bell led the Tigers to District 2 Championship. Coach Bell has been recognized as conference Coach of the Year 5 times.

Dusty Dinkins (South Iron HS Boys)

Dinkins is a grauate of South Iron HS/Three Rivers CC/Southwest Baptist University. As a player, Dinkins earned several accolades including: AP All-State, BRL All-Conference MVP, Dream Team MVP and 2X Mid-America Intercollegiate Athletic Association All-Conference Membre. As a coach, Dinkins has been at the helm of the South Iron Panthers for the past 11 seasons. His teams have compiled an overall record of (241-66). During the past 11 seasons the Panthers have been: (9X) AV Thanksgiving Tournament Champions, (8X) BRL Conference Tourney Champions, (1X) Bob Sechrest Jr Christmas Tourney Champions, (4X) District Champions, (1X) Class 2 Final Four with a Second Place finish. As a result of his teams' successes, he has been awarded: (2X) KTJJ Dream Team Coach of the Year, (7X) BRL Conference Coach of the Year, (4X) BA SApports All-Star Extravaganza Coach, (5X) MOBCA District Coach of the Year.
